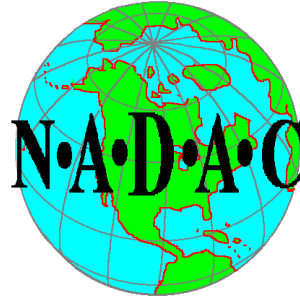

NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations and agree to abide by all rules in effect at the time of this trial.

No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

****Dog must be registered with NADAC and have a valid registration number before entries will be accepted. Pending numbers are no longer accepted.**

Current wither heights and jump heights, breed exemptions, a description of classes, levels and divisions are included in the current Exhibitors Handbook. Through submission of their entry, the exhibitors acknowledge they are familiar with the rules in the current Exhibitors Handbook.

THE MANAGEMENT will not be responsible for the loss or damage to any dog exhibited or for the possessions of any exhibitor, whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care, custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of fees paid will be made.

NO AGGRESSIVE DOGS OR PEOPLE ARE ALLOWED. This trial is to have fun with your dogs and enjoy the sport of agility. PLEASE KEEP YOUR DOG ON A LEASH WHEN NOT IN THE RING. DOGS MAY NOT BE TIED TO A CRATE OR TREE OR ANYTHING UNDER ANY CIRCUMSTANCES. PLEASE CLEAN UP AFTER YOUR DOG IN ALL AREAS.

IMPORTANT. Please check your dog's NADAC registration number on your trial confirmation as soon as you receive it; also, please check the copy of the results posted at the trial. You should report any errors to the Trial Secretary immediately.

NADAC records trial results as they are submitted by the host clubs/groups. The individual trial results submitted by the club are uploaded to the files section of the NADACAgility@yahogroups.com list within two weeks after the NADAC office receives them from the club. The trial results will remain on the list for at least thirty (30) days. Please accept the responsibility to review those results, and check that your registration number and qualifying points, as reported by the club, are correct. You can join the www.NADACAgility@yahogroups.com list and set your settings to "no mail". You will be able to view trial results and check for any possible discrepancies, without receiving list mail. If you find an error in the reporting of your dog's qualifying points or registration number, please contact the host club. The host club is responsible for correcting any errors and informing NADAC.

Levels. Points earned at a higher level of a class, prior to the completion of the lower level title, will not be banked by NADAC for future use. If a dog earns points in a level of a class that they are not eligible to title in, those points will not be added to the dog's records.

AGREEMENT

Must be signed and accompany all entries.

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of enter dog. In consideration of acceptance of this entry:

- 1.1 As used here NADAC means North American Dog Agility Council, Inc., its members, officers, directors, employees, show chairs, show committees and agents.
- 1.2 Exhibitor/owner, agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccinations is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fitting, show rings, parking areas and the presence of unfamiliar animals and people: exhibitor and owner assume the risk of any harm arising from these.
- 1.5 Exhibitor/owner release NADAC (including NADAC officers, directors, employees and members), BRAG (including officers, directors, employees and members) and Yellowstone Dog Sports (officers, directors, employees and members) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
- 1.6 Exhibitor understands there is a returned check fee of \$25.
- 1.7 Exhibitor understands that they are responsible for their and their dogs conduct at the show grounds during the entire weekend. Failure to comply can be a reason for dismissal from the trial; including no refund of monies and elimination of all scores obtained during the trial.

In consideration of the acceptance of the entry, I/we agree to abide by the rules and Regulations of NADAC in effect at the time of this trial, and by any additional rules and regulations as approved by the board of NADAC for this trial. I/We certify that the dog entered is not a hazard to persons or to other dogs. I/We further agree to be bound by the "Agreement" printed above.
